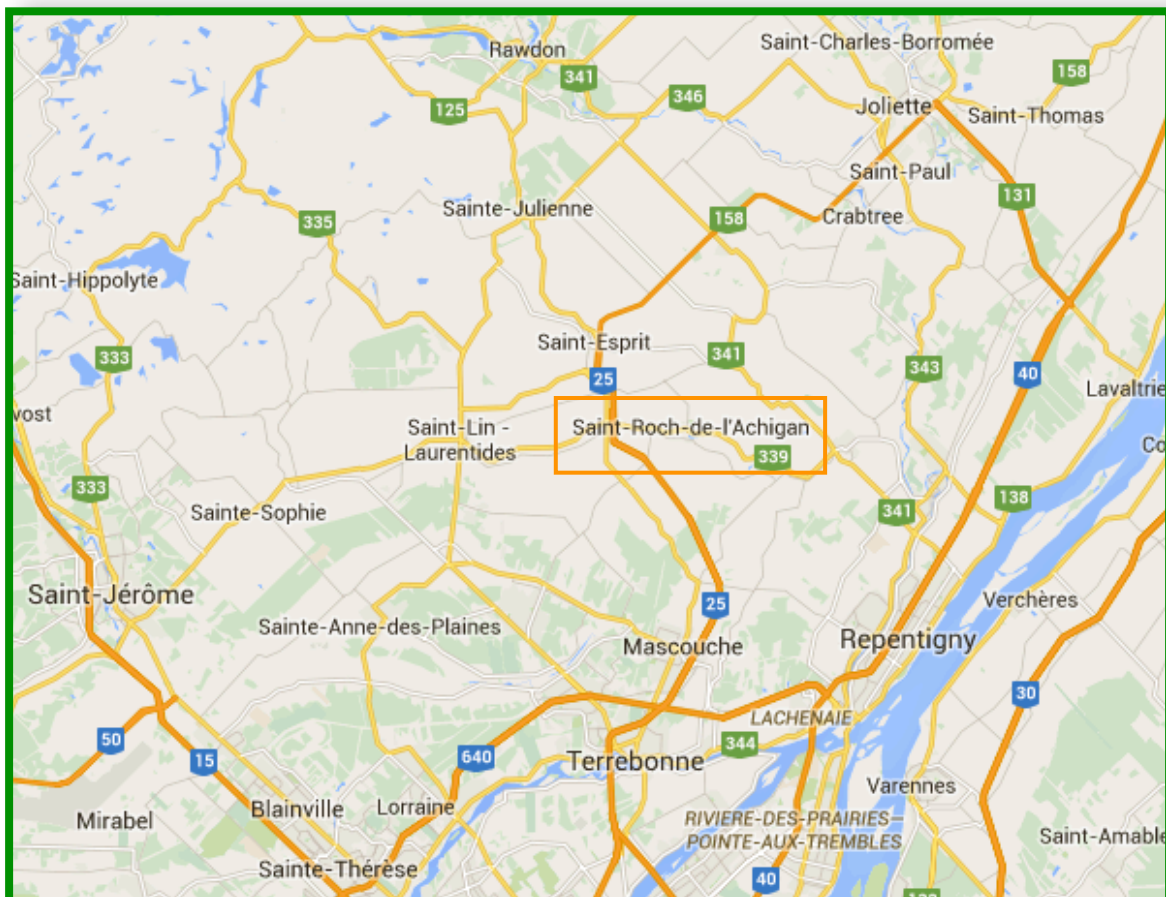

# *The Municipality of Saint-Roch-de-l’Achigan*

MRC of Montcalm – Population 5000 inhabitants

The Municipality of Saint-Roch-de-l’Achigan belongs to the administrative region of Lanaudière. Situated less than 40 km from Montreal and some 15 kilometers east of Saint-Lin-des-Laurentides, Saint-Roch-de-l’Achigan is divided by the Achigan River that runs from east to west. Founded in 1787, Saint-Roch-de-l’Achigan was named after the seigneur of l’Assomption, Paul-Roch de Saint-Ours de l’Eschailion (1747-1814), son of Pierre-Roch de Saint-Ours (1712-1782).

In the heart of a natural landscape where reigns harmony between agriculture and other activities, Saint-Roch-de-l’Achigan offers a milieu full of life, charming and animated, a milieu that has preserved its natural assets, its history, its heritage, a milieu that has developed its unique village character. Discover its historical buildings named in the Repertory of the Cultural Heritage of Quebec, such as the Old-Convent and the Presbytery, and make a stop «Au Moulin Bleu», this buckwheat flour mill dating back to 1860.



## *Brief History of Saint-Roch-de-l'Achigan*

Its territory, situated mostly in the seigneurie of l'Assomption, is developed in the years 1750 by settlers who come in a great part from the parishes of l'Assomption and Mascouche. In order to respond to the needs of his censors, the seigneur Pierre-Roch de Saint-Ours proceeds in 1771 with the building of a common mill on a land today known under the name of "l'Île Masson". Furthermore, he ardently wishes that the church will be built in the area surrounding the mill and he undertakes, on this subject, an assiduous correspondence with the bishop of Quebec, Bishop Jean-Antoine Briand.

His son, Paul-Roch, succeeds him upon his death in 1782 and he maintains this desire. As far as he is concerned, Bishop Briand privileges a location situated more in the centre of the parish, north of the river and near the mouth of Ruisseau-des-Anges. He hopes thus to respond to the wishes expressed especially by the inhabitants of the Rang-du-Ruisseau-des-Anges. Due to the rapid increase of the population, he allows in spite of the divergence of opinions, the opening of church registries in 1787. The census of 1790 reports that there are already some 1313 inhabitants settled in the territory. At the beginning of the 1790's, Bishop Jean-François Hubert, the new bishop of Quebec and Paul-Roch reach an understanding as to the choice of a piece of land located in the centre of the village. Yet, it will take some years before the parish is provided with a church. Serious differences among the inhabitants delay the construction and it is only in 1803 that they may enjoy a place of worship corresponding to their needs.

In 1808, a first dismemberment of the parish comes about with the foundation of the parish of Saint-Esprit. In 1832, the religious authorities canonically recognize the existence of the parish. A second dismemberment occurs in 1835 with the foundation of the parish of Saint-Lin. The municipality obtains its civil recognition in 1842. It is abolished in 1847 to the benefit of the municipality of the County of Lachenaie and it is again re-established as a distinct municipality in 1855. On the territory of the parish can be found two municipalities, that of Saint-Roch-de-l'Achigan and that of Saint-Roch-Ouest. In 1921, a small part of the countryside is detached to form the municipality of Saint-Roch-Ouest. Both municipalities are part of the MRC of Montcalm and of the region of Lanaudière.

Currently, the municipality of Saint-Roch-de-l'Achigan counts some 5000 inhabitants. Since a few years now, there exists an important residential development. An industrial park created some 30 years ago along Autoroute 25 has allowed the diversification of economic activities. In spite of these changes, agriculture has not been abandoned and the growing of vegetables is part of an intensive activity. The municipality of Saint-Roch-Ouest, whose population is slightly inferior to 300 inhabitants, is essentially rural, living mostly on agriculture.

One must recall that since 1921, the parish was divided among two municipalities, that of Saint-Roch-de-l'Achigan and that of Saint-Roch-Ouest. It is to be mentioned that in January 2013, the parish of Saint-Roch-de-l'Achigan, as well as its neighbour the parish of l'Épiphanie, have been abolished and have been replaced by a new parish – Bienheureuse-Marie-Rose-Durocher – which presently comprises four municipalities, that of Saint-Roch-de-l'Achigan, Saint-Roch-Ouest, Épiphanie-Village and Épiphanie-Country.

## **Homage to Laurent Mercier senior**

By Mr. PIERRE BROSSEAU, READ AT THE FUNERAL ON JANUARY 3 2015

My dear Cécile,  
Claude of whom we all feel the presence,  
Martine my little sister, my old friend Richard,

It was on an April morning in 1976 that I made the acquaintance of he who still assembles us today in spite of his recent departure. That morning, I was replacing at short notice, before the Agriculture and Food Marketing Board of Quebec, my senior associate at the time, Pierre-Luc Blain. I had asked Pierre-Luc to give me a physical description of Laurent so that I could recognize him. He had answered me that if someone shook my hand and that my forearm disappeared completely in his hand, it was him. After that meeting, Laurent invited me to lunch with him at the «Poulet Doré» on Sainte-Catherine Street. He had a special sweet tooth for a certain desert which we could absolutely not mention to Cécile...

My friendly and professional friendship with Laurent started at the moment he asked me what I knew about «poultry» and what I replied: «Nothing except what I see in my plate. » He had appreciated that brief and frank answer. It was the time when the national plan for a Turkey Marketing Board was at a trial stage and a national plan for a Poultry Board was in negotiation. Dissidence at the provincial level was at its peak in the field of egg marketing and we could see at the horizon coming difficulties in the field of poultry production. Implementation of a program of marketing boards was progressing slowly and divergent interests were bursting from all sides.

Laurent was seating as an executive on the Turkey Marketing Board, the offices of which were located in Winnipeg, he was an executive for the UPA whose offices were situated at 515 Viger in Montreal and he held positions at the presidency of the Federation and of the Syndicate of Lanaudiere. It was the time when he drove a white New Yorker, long as a street corner, and no matter what time of day it was or what distance was involved, Laurent would return home after a day of meetings to be close to his dear Cécile and his children. To him, his family was his priority with no possibility of compromise.

It is during that period that Laurent asked me to accompany him as a translator to the meetings of the Turkey Marketing Board and for the negotiations which led to the establishment of a Poultry Board. It was useful to him that his translator be also a lawyer. Laurent traveled constantly across Canada, multiplying reunions, meetings with governmental authorities, with various production Boards, for conferences and visits.

In spite of an evident language barrier, he was welcomed wherever he went. All people in the field of agriculture knew him and respected him. But then why?

Firstly, because he was of a very gentle nature, and then, because he had a very deep knowledge of his files, never sought his own personal advantage, believed firmly that everyone has a right to find a place under the sun and that, at the end of a negotiation, all parties must come out as winners. He held closely to heart the interests of the producers of Quebec, but insisted that the interests of our partners of the other provinces were always to be taken in consideration. His grand ideal, and thus his primary motivation were to obtain for the totality of the producers a just and equitable income for their produce.

For the young, such an ideal can be considered today as self-evident, but at that time, nothing was taken for granted, and the producers had to fight for their survival. Never forget that the three pillars for a good marketing policy, that is: control of the production, control of the importations and a decent pricing policy, were excavated, entrenched and cemented by such great men as our friend Laurent.

I could pass hours sharing with you different anecdotes that used to happen on every trip. One that I will never forget is the one that happened during a flight from Calgary to Ottawa when he sat on Minister Whelan's green Stetson. When he arrived in Ottawa, the hat was unrecognizable, the minister enraged and Laurent split in two to hide his so distinctive laugh.

We owe it, as citizens and as producers, to visionaries of the likes of Laurent to be able to live under the present agricultural marketing boards. As citizens, our producer-friends live off their produce and of this achievement, we must be proud. They provide us with excellent produce at a just price. This result is the fruit of tenacious men, intelligent, reasonable and responsible as has always been our old friend Laurent.

On the other hand, since there are always two sides to a coin, it is also due to Laurent if candy bowls in hotel meeting rooms are now smaller; after all, these establishments are also conscious of their profits. Laurent has always made it a priority to work at the collective well-being of the producers of Quebec and of that of all Canadian producers. This well-being was his primary motivation and this motivation is what kept him active for so long.

We all owe him a lot. It is not necessary to view in detail all the functions he occupied during his long career. I invite you to read his homage on the internet site «Temple de la renommée de l'agriculture du Québec».

Laurent, your picture is always on my desk next to that of my grandfather, my father, of Ovide Lebel and of Marcel Trudeau. It will remain there for, to me, you continue to be a source of inspiration.

You will have occupied many essential functions in the midst of our society. You will have instilled in us principles of justice, equity and common sense, always with respect, frankness and honesty. Finally and to sum up, we will have been privileged to have travelled some ways by your side.
